Supervisor Giunta called the Public Hearing to order at 7:20PM.

Town Attorney, Dan Schum verified the Legal Notice was properly published in the official newspaper as required by law.

CONSIDERING CITTA PROPERTIES LLC., TO REZONE 1151 SPENCERPORT RD., FROM SINGLE FAMILY TO MULTI-FAMILY RESIDENCE

Supervisor Giunta asked if the applicant was present.

Paul Surace and Cara Thibault, 1376 Harris Rd, Webster, recently purchased the property, that was once Zoned Multi-Family, then Rezoned to Single-Family and now they want it rezoned back to Multi-Family. The intention is to break it down to (3) three-family Residence. They need to still meet with their architect

Supervisor Giunta asked if the (3) three tenants have separate utilities, like washer and dryer or will it be shared?

Ms. Thibault replied each unit will have its own washer and dryer and appliances

Mr. Surace, it's (43,000) forty-three hundred square feet, so there's plenty of space, with plenty of parking.

Ms. Thibault, there's a parking lot behind

Councilman DiPonzio aske if there is (1) one entrance or will there be (3) three separate entrances

Ms. Thibault, there will be (3) three separate entrances, right now there's a front entrance and a back entrance and also an egress entrance from the basement, but want to add a side entrance for the third unit

Councilman DiPonzio asked how many cars would fit in the parking lot?

Mr. Surace replied about 10 cars

Attorney Schum asked if the building is presently sprinkled or not?

Ms. Thibault, not a sprinkler system, but it does have a central alarm in it like in a school

Supervisor Giunta, asked if alarms will in installed in each unit? If so, to be sure there are permits for them to be monitored.

Ms. Thibault, Yes there will be. Mr. Surace, we have an architect and he'll get all the permits needed and be sure we're up to code

Supervisor Giunta asked if any more comments or questions? None.

Then opened to the public, hearing none, closed the public hearing.

Supervisor Giunta, unfortunately this will need tot be TABLED till the next meeting August 2, 2021 due to requiring the response from the County. There doesn't seem to be anyone here

ADOPTING A SEQR RESOLUTION - TYPE II ACTION AND SUPPORT FOR STATE MS4 MAPPING GRANT APPLICATION

RESOLUTION 131-21 Motion by Councilman Cordero to approve the Negative Declaration of the SEQR

WHEREAS, the Town of Gates, as a designated Municipal Separate Storm Sewer System (MS4), is responsible for developing and maintaining a storm water management program that will reduce the amount of pollutants carried by storm water during storm events to waterbodies of the State, thereby improving water quality and recreational use of those waterways; and

WHEREAS, a component of the MS4 storm water management program is comprehensive mapping system of the Town's storm water infrastructure to assist in the conducting of illicit discharge investigations, and identifying and mitigating significant sources of pollution that may be contributing to the impairment of those waterways; and

WHEREAS, the Town has identified a three phased MS4 mapping improvement project to enhance its current mapping, and it looking to begin Phase 3: *Round Pond Creek Watershed*. This phase will complete the project, allowing the Town of Gates and its staff to work effectively with neighboring MS4 communities and regulatory agencies in protecting local waterbodies; and

NOW, THEREFORE, BE IT RESOLVED that the Town of Gates Town Board (hereinafter referred to as Town Board) does hereby classify the information collection and mapping of existing infrastructure related to updating its MS4 mapping as a Type II Action under Sections 617.5 (c) (17) & (18) of article 8 of the New York State Environmental Conservation Law, the State Environmental Quality Review Act (SEQRA); and

BE IT FURTHER RESOLVED, that Type II Actions are not subject to further review under SEQRA provisions as these actions have been determined not to have a significant impact upon the environment or are otherwise precluded from environmental review in the Environmental Conservation Law, article 8.

BE IT FINALLY RESOLVED, that the Town Board in making this classification has satisfied the procedural requirements under SEQRA and directs this Resolution to be placed in the file on this Action.

WHEREAS, the Town of Gates, as a designated Municipal Separate Storm Sewer System (MS4), is responsible for developing and maintaining a storm water management program that will reduce the amount of pollutants carried by storm water during storm events to waterbodies of the State, thereby improving water quality and recreational use of those waterways; and

WHEREAS, the Town of Gates (hereinafter identified as Town Board) has identified the need for continued improvements to its current storm water infrastructure mapping, providing a more comprehensive mapping system to assist in the conducting of illicit discharge investigations, identifying and mitigating significant sources of pollution that may be contributing to the impairment of waterways, and allowing the Town of Gates and its staff to work effectively with neighboring MS4 communities and regulatory agencies in protecting the State's waterbodies; and

WHEREAS, the New York State Department of Environmental Conservation provides a competitive, statewide reimbursement grant program for MS4s to modify and update their mapping through the Consolidated Funding Application, Water Quality Improvement Project (WQIP) program; and

WHEREAS, any funding awarded under this Grant Application will be used for Phase 3: *Round Pond Creek Watershed*, of at three phased projects to update the existing MS4 mapping making it more comprehensive; and

WHEREAS, the Town Board has determined, under a separate resolution, the update of its MS4 mapping is a Type II Action.

NOW, THEREFORE, BE IT RESOLVED that the Town Board does hereby recognize and does fully support the submission of a Consolidated Funding Application, WQIP on behalf of the Town for Water Quality Improvement Project funding for MS4 Mapping.

BE IT FINALLY RESOLVED that the Town Board does hereby accept that they shall provide at least 25% match of the total of any grant funding awarded, in the form of cash contribution or in-kind services.
