#### 7:15PM PUBLIC HEARING

### CONSIDERING CONDITIONAL USE PERMIT FOR LISA BRUNSON TO OPERATE, PURE IMAGINATION CAFÉ IN A NB DISTRICT, AT 2997 BUFFALO RD.

Supervisor Giunta called the Public Hearing to order at 7:28PM. The Town Attorney verified that the Legal Notice was published as required by law.

Lisa Brunson, applicant of 2997 Buffalo Rd., has operated Pure Imagination Café for a little over a year with food and temporary town approved outdoor seating during COVID-19, but not going forward.

Supervisor Giunta asked about the about the menu, if anything different than normal menu was added from when they initially opened. Serving sandwiches / drinks. Now they are looking to add alcohol and asked if they have applied for a liquor license.

Ms. Brunson, answered menu to stay same with sandwiches and salads along with a few new items, but still using the same cooking apparatus, not adding grills. They have applied for a liquor license and do have a temporary one to serve beer and wine only, but no hard liquor. It's the only change since opening a year ago.

Supervisor Giunta asked about the hours of operation

Ms. Brunson, replied hours have be reduced due to COVID, so Monday-Thursday open till 6, but when returned to normal hours will go back to, Monday-Saturday 7:30AM- 8:00PM and Sunday 9:00AM-5:00PM

Councilman Tucciarello, asked if getting todays approval would be part of getting a liquor license application? Stated his mom really loves going there.

Ms. Brunson replied yes and it's the only thing that changed since getting original since application was made and thanked councilman Tucciarello for kind words

Councilman Loughlin added he's been there several times and his children enjoy it and the children can play while the parents sit and have a cup of coffee.

Supervisor Giunta agreed it's a very nice establishment and invited anyone from audience up to speak, hearing no one closed the public hearing.

### **AUDIENCE PARTICIPATION**

Don Ioannone, 4099 Lyell Rd, had a copy of the October, 1964 Gates Chili News, with an article that the Gates Library would be formerly rededicated as the Colonel Robert N. Abbott Memorial Library on October 27, 1964 at 10:30AM with the public invited. Mr. Ioannone questioned how the designation got lost with the move from Buffalo Rd to Elmgrove Rd., which is just names The Gates Public Library? He has spoken with several people about this, including with Greg Westberg from the recreation commission with talks about renaming the Gates Memorial Park to memorialize the Colonel's memory.

Supervisor Giunta asked Anna Souannavong, the Gates Library Director to possibly research this matter.

### **OLD BUSINESS**

# CONSIDERING A CONDITIONAL USE PERMIT FOR G & I IX EMPIRE WESTGATE PLAZA, LLC C/O DLC MANGAGEMENT TO OPERATE FUN CITY TRAMPOLINE PARK IN A GENERAL BUISNESS DISTRICT AT 2000 CHILI AVE.

Councilman DiPonzio motioned to lift the discussion off the table.

F L Gorman, attorney of Harris Beach PLLC, Thanked the Board for taking the application, again, and has looked over all the proposed conditions and agree with everything with the exception of needing to add Sundays which was missed in the original operating hours.

Supervisor Giunta, reviewed the conditions that we have been going back and forth about including the

• Operating Hours;

Sunday – Thursday 10:00AM -8:00PM Friday & Saturday 10:00AM-9:00PM

Closing at 8:00PM and 9:00PM helps the Town, with Walmart Closing at 10:00 and the Police Dept. Shift Change Time [to give ample time to respond if needed]

• Fridays & Saturdays after 6:00PM anyone 17 and under MUST be accompanied by a Parent/ Legal Guardian, which MUST remain on site for the duration of Ticket Time.

This is similar to how Movie Theaters proceed on Fridays & Saturdays.

- No-one is to leave the Trampoline Park within their paid Ticket Time and return, unless time is expired and purchase a new Ticket.
- Security:

Both Inside and Outside of Park during Hours of Operation and continued outside Patrol, 7 days a week.

Security Cameras, requested Inside and Outside the facility, Door Entrances and Exits

Along with the perimeter of the Parking Lot, in front, around, and back of building

- "Teen Nights", Not to be publicized [unfortunately, historically brings problems when it is can be called something else]
- Plaza to be maintained including sweeping and trash pick-up, as well as cart pick-up twice a day
- Continue with "No Overnight Parking", of tractor trailers
- If DLC were to sell the plaza, the property maintenance agreement and security contract would transfer to new owners.

Supervisor Giunta, added these are some of the conditions set forth though-out the process of this project.

Chief VanBrederode, stated it's been a great relationship with Mr. Levy from Buffalo addressing some liter issues and the trucks, but has been very cooperative with us and believes it would be a safe as long as all the conditions are met and would be in a good position to hold a safe operation there.

Supervisor Giunta reminded everyone this would be an annual Conditional Use Permit that would require renewing each year.

Councilman Loughlin, asked if during the pandemic are these types of facilities currently operating and if not, what would be the proposed time of opening?

Mr. Gorman responded, some other facilities are open, some are limited hours, some at reduced occupancy. This may be their first location in New York.

Councilman Loughlin asked if other trampoline facilities in the area are open to capacity, on reduced occupancy, or closed due to the pandemic?

Mr. Gorman responded that they are on reduced occupancy, bowling allies have been allowed to reopen with reductions and this is being treated with the same business practices.

This particular facility has a significant build-out in its 30-thousand square feet and would not be open till Spring 2021.

Supervisor Giunta opened discussion to anyone with comments, questions, or concerns

Attorney Schum, added that there was some discussion and the prior meeting about registration of participants and how the process is done as well as conditions on who is eligible to resister. Under 17 with a parent / "adult" has a lot of wiggle room and would suggest removing "adult" and make it parent/legal guardian. The idea is that the "adult" has a legal responsibility to the child.

Supervisor Giunta, agreed that is a valid point and would need to be changed. Fridays and Saturdays after 6:00PM anyone under 17 would need to have a legal parent or guardian and remain in the facility.

Mr. Gorman added that is a bit different than movie theater, but is on the mercy of the Board

Supervisor Giunta asked Mr. Gorman if he understood the reasoning behind the attorney's comments/concern. Mr. Gorman answered he did

Supervisor Giunta responded then it would change the condition to Parent or Legal Guardian

Miriam Rivera, 4 Bru-Mar Drive, commented that if it's stated Parent or Legal Guardian, then birth certificates would be needed to show proof. Ms. Rivera feels it should be Parent or Legal Adult 25 or older. She would feel more comfortable having someone 25 and older being responsible for her children rather than 18.

Councilman Tucciarello is not sure 25 is the right number, and feels some discussion is needed.

Attorney Schum suggested making it all three, Parent, Legal Guardian or Adult over 25

Mr. Gorman responded it would assist the business reality of the operating location

Supervisor Giunta reiterated that it would be stated as anyone under the age of 17 would need to accompanied by a Parent/Legal Guardian/ or Adult 25 or over and remain in the facility
