### 7:15PM PUBLIC HEARING

Supervisor Giunta called the Public Hearing to order at 7:15PM.

# CONSIDERING A CONDITIONAL USE PERMIT FOR CARMEN EVENSON TO OPERATE JOE'S KWIK MARTS #481, AT 1952 LYELL AVE.

Supervisor Giunta explained Ms. Evenson was not able to attend in person, but was on via phone.

Councilman Tucciarello asked if Ms. Evenson currently has 480 stores making this location #481 and where are her stores located?

Carmen Evenson, Territory Manager, No, she actually has (5) five in the Rochester area. It's just a number based on other stores they have throughout the U.S. Farmington, Ridge Rd, Lyell Ave. some in Greece, Winton Rd. and Spencerport

Supervisor Giunta asked if they are all named the same (Joe's Kwik Mart)

Ms. Evenson, yes, all are Joe's Kwik Marts. She was actually on the Thruway sites and was lucky enough to get into Rochester

Supervisor Giunta asked if these will be Exxon / Mobil's and also the hours of operation, will they remain the same or change?

Ms. Evenson it will be Exxon or Mobil and the hours will remain the same 24-hour operation, seven-days a week

Councilman DiPonzio any changes of operation then what it is now, with food service and tobacco sales

Ms. Evenson, no changes, deli, gas. It's just changing over to Joe's Kwik Mart

Councilman Tucciarello asked if there will be any changes to the esthetics of building, looking at another location with a different architectural design, or staying with the current style of the building on Lyell Ave

Ms. Evenson it's going to stay pretty much the same, just add Joe's and the red signage at the pumps, Mobil advertises it uses synergy. Will also paint to freshen up.

Supervisor Giunta, if approved, she will need to stop into the Building Dept. for signage information and permit.

Supervisor Giunta asked the Board if there were any additional comments or questions. He then opened up to the audience and asked if anyone was hear for the Public Hearing. Hearing none closed the public hearing.
