7:15 P.M PUBLIC HEARING

TO CONSIDER A CONDITIONAL USE PERMIT FOR DEVAN BLAZEY TO OPERATE SUMMIT K-9, A DOG TRAINING FACILITY INCLUDING BOARDING AT 1555 BROOKS AVE. A (GI) GENERAL INDUSTRIAL DISTRICT

The Town Attorney, Dan Schum verified that the Legal Notice was properly published as required by law.

Supervisor Giunta asked if the applicant was present and would come up to speak on this application.

Devan Blazey, 90 Edgemont Rd., in partnership with the building owner lease space to operate their existing mobile training program to a brick and mortar. It's very structure, with a day camp and want to include some extra onsite options, like limited boarding for some that are currently in program or have been prior.

Supervisor Giunta asked how long is a dog stays if in boarding?

Ms. Blazey replied it would be based on a case by case and is done week days and the dogs go home for the weekend. There are some out of town clients, so it could run over the weekend. It is mainly one to six (1-6) weeks, but have not had requests for a month in the past.

Supervisor Giunta asked how many actual kennels to board at one time?

Ms. Blazey replied they use crates instead of permanent kennels and wants to be flexible in the amount. The average is twenty to forty (20-40)

Supervisor Giunta asked the hours of operation?

Ms. Blazey replied loosely between 7:00am-9:30pm for group classes or puppy course. Day camp is 7:00am to 6:00pm weekdays. As for weekdays, still haven't nailed down an exact time yet, but looking at 7:00am to 9:30pm

Currently most of the operations are Monday -Saturday, but looking at growth the next few years.

Supervisor Giunta asked if the trainings are for obedience, behavior or a variety of trainings?

Ms. Blazey mainly obedience with pet dogs. No Police dog trainings. Main goal is to create ways for clients to continue training and pass low level behavior issues into something more recreational and long term

Attorney Schum asked if there will be any outdoor runs or access?

Ms. Blazey the majority would be indoors, it's about fifty-five hundred (55,000) square of space to have access to have play groups, structured trainings. She would like to add fencing in the

future for two (2) outside potty yards, but most of the operations would be inside. They have a van and would do field trips.

Councilman Tucciarello asked who occupied the space previously?

Ms. Blazey is not sure, heard that perhaps a printing shop at one point.

Councilman DiPonzio as far as boarding the dogs overnight, are they left unattended?

Ms. Blazey, staff is there from 6:00am to 11:00pm, but not likely to have overnight staff, but does have video monitoring and is able to check on the dogs, but no coming or going

Councilman DiPonzio asked as far as security, cameras and alarms? Asked if a special insurance is required, because some dogs are very expensive?

Ms. Blazey is very stringent on that and also likes it to be able to monitor everything and watch to be sure everything is good. As for the insurance, yes there is pet insurance

Supervisor Giunta asked how many staff will be employed?

Ms. Blazey currently there are four (4) including herself, but will add more as the program grows, but doesn't have a specific number

Supervisor Giunta asked if its part of their policy dogs being licensed is a requirement, because there is a town ordinance.

Ms. Blazey, doesn't have that in their policies, and is not sure how-to track, but if it is required by the town will add along with vaccinations.

Attorney Schum asked if there is a dog waste prevision?

Ms. Blazey, immediate removal into doggie bags and put in private dumpster which is onsite and regularly emptied.

Supervisor Giunta asked if anyone in the audience had additional comments?

Sarah Klingenberger, 71 Lyndale Dr. They are clients of Summit K-9 which helped tremendously with their two (2) dogs. They are delighted to have them on this side of town, they currently go to Henrietta. They offer trainings and other things and is very excited.

Supervisor Giunta again asked if anyone from the audience wanted to speak for or against this, hearing none closed the public hearing at 7:27pm .
