7:30PM REGULAR TOWN BOARD MEETING

Supervisor Cosmo Giunta called the meeting to order at 7:30PM. He began with a moment of silent prayer and Pledge of Allegiance, led by Councilman Cordero

There were no revisions made to the minutes of the Public Hearings and Regular Town Board Meeting held August 1, 2022. Minutes will stand, be published and made available on the website and Town Clerk's office.

AUDIENCE PARTICIPATION

Don Ioannone, 4099 Lyell Rd. concerned with what's happening not just in the USA, but around the world and is suggesting there be a police officer present at all public meetings held here at the Town Hall for the Town, Planning, and Zoning Board meetings. He also mentioned that he sent a letter to the Gates Fire District Clerk announcing his candidacy for Fire Commissioner to have his name added to the ballot for Fire Commissioner.

Supervisor Giunta asked Police Chief Long if it would be possible to have police presence at meeting?

Police Chief Long respond, perhaps but would like discuss further off line.

Laurie Clocksin 69 Coldwater Rd., wanted to confirm something she read about the Amazon facility delaying their opening and if so, for how long and why?

Supervisor Giunta confirmed yes they are delaying the opening due to supply chain issues for completing the project on the inside of the building. The exterior is complete and believes it'll be delayed approximately (6) six-months. He visited the facility roughly 3 weeks prior and was advised that once the contractors confirm everything interiorly is done will hand off as completed. Amazon then will come in and start their process of installation of racks and robotics. He stated the backlogs are happening everywhere including the town as it's still waiting on a piece of equipment since last year. As far as Amazon, it's all the information that has been cascaded to him and he has no reason to doubt them. They have spent over three-hundred million dollars on the facility and doesn't believe they will be going anywhere and are here to stay.

Mrs. Clocksin asked Attorney Schum if the delay represents a breach of contract in any way if not for the Town of Gates, but the County of Monroe for the tax break.

Attorney Schum, stated it's a great question, but No. The applicant (the owner of the property in this case) has the opportunity to apply for when the tax break starts and typically they do not apply till the building is fully assessed and if full operation. The contract in a (10) ten-year exemption, but the start date is flexible based on when the applicant applies, so the Town of Gates will not "suffer" if you will any tax reduction until they apply. It's unlikely they would apply if the building is not fully assessed and operational.

Mrs. Clocksin, but if they don't open their doors then it would, right? Did they pay taxes on building?

Attorney Schum, yes and the assessor has gone through this. March 1st is the taxable state, so whatever taxable status that building was in on March 1st is what they will be taxed on. It appeared on the school tax bill, which will tell you what it was assessed for from March 1, 2022-February 2023. He doubts it's fully assessed because it wasn't fully completed or operational on March 1st. They will probably wait till February/March of 2023 to apply for exemption.

Mrs. Clocksin continued that she had terrible flooding this past winter, which they have never had before and her basement flooded with ground water twice and her husband says if you pave over a piece of property or space that huge, the water table will be moved, and considering it's practically on top of wetlands, also with pipes freezing in the winter and then thawing, a problem could be cause. She just doesn't want flooding again.

She also recently noticed a street light at the end of her driveway which is shining very bright and wants to know when the bulbs are being changed to smart street lights

Supervisor Giunta stated the Town purchased all the street lights and RG&E has been converting them to LED to save money for the town utilities

Highway Superintendent Kurt Rappazzo, added the town received a grant from NYSERDA to cover some of the cost. Over 700 fixtures will be replaced.

Mrs. Clocksin n doesn't think the Smart light fixtures is a good thing. Supposedly it will save money long term, but hasn't proven true. There are several issues, privacy, health, and it's just a part of the internet phase. Everything is connected and if you value your privacy, you will not want a smart street light.

Mr. Rappazzo, the light fixtures themselves are not internet ready, not the Smart fixtures they are strictly LED bulbs

Mrs. Clocksin, but they have the capacity

Mr. Rappazzo, not that he's aware of and the town has no way of controlling the lights

Mrs. Clocksin knows the town doesn't, but they can be

Mr. Rappazzo will look into it for her peace of mind

CPUB CHAIR, CHRISTINE MAURICE TO PRESENT THE FINAL COMPREHENSIVE PLAN UPDATE TO TOWN BOARD FOR REVIEW

CPUB Chair, Christine Maurice in January the Town created CPUB which is a Comprehensive Plan Update Board. A special board with a purpose to write an update to the towns master plan, which was last done five-years ago in 2017. The goal is for the town to adopt the proposed updated plan by the end of 2022.

Mrs. Maurice acknowledged the members present of the board; Patty Redfern, Brom Bianchi, Steve Zimmer, Virginia McIntyre and Ed Mauro missing was Mike Wall for all their efforts, knowledge, and time to this project for the past 8 months.

They spent the first three (3) months gathering input from the community, other towns, and folks at Monroe County on their updates with in their own plan this year, including attending their public forum.

They created surveys for both home and business owners (hard copy & on-line). Held a public forum in April as well four (4) focus groups in May and June, one of which was with town department heads, some of the them present in this meeting participated and she is very thankful for their input. All of the efforts that were collected from the community are described in detail, including surveys, public forum materials, and some photos from the events.

They have updated the 2017 plan with forward looking recommendations, all with underline intent of assuring Gates remains a terrific place to live and work. All of the data charts from 2017 have been updated.

Mrs. Maurice thanked, the Town Supervisor, Cosmo Giunta and Highway Superintendent Kurt Rappazzo who were both very supportive and very involved with their time and ideas as well as Deputy Town Attorney Rob MacClaren, attending several of the board meetings and always taking her calls. She continued recognizing all the people involved, especially, Lily Alberto confidential secretary to Supervisor Giunta in the whole process which are listed on page two (2) of the 2022 Comprehensive Master Plan.

This completed Phase I of the five (5) year plan which she has handed to the Town Board for their review as well as going through NY State mandated reviews and a Public Hearing before adopting later this year. Mrs. Maurice requested the CPUB stay intact until it is adopted in case they need to be brought back after any of the reviews.

Mrs. Maurice thanked the board for putting trust in CPUB to deliver a Comprehensive Plan Update and believes this proposal has met and even exceed the expectations of the Town Board.

Supervisor Giunta expressed a heartful "Thank You" to Christine for spear heading this project and taking the roll of Chairperson for this board. He also thanked all the CPUB board members who participated, the long hours spent and many sessions it took to put this plan together. He watched them go through this process and was aware of some of the difficulties at first, but felt because of the diverse knowledge from planning, zoning, private sectors, EMS and other backgrounds they all brought value. All of them hey came together and remarkably in seven (7) months got this done. He reiterated his gratitude and accepted this plan and the board will review over the next couple months.

Councilman Cordero added the CPUB did an awesome job and appreciated Mrs. Maurice's communication and keeping them updated throughout the process and thanked her and the team for a job well done.

Councilman Loughlin also thanked Mrs. Maurice and the board and knows they exceeded the expectation that was set and looks forward to reviewing the plan.

Mrs. Maurice thanked the Town Board on behalf of the CPUB for their nice words.

Councilman Tucciarello appreciates all their time and effort and in the limited time he had it and went through it, sees it's well laid out and reads extremely well with great information and looks forward to sitting down and really going through it completely.

Councilman DiPonzio is not surprised, because he knows most of the CPUB members and appreciates all of their efforts and how well thought out and thorough it is.

Supervisor Giunta agreed it being thorough with eighty-seven (87) pages. They will go through it and if they have any questions will be in contact. There will be a copy in the Town Clerks office, a Public Hearing and hopefully adopted in November or December. He thanked them all again for doing this. It's a great collaborative effort.
