## PRESENTATION OF THE EXCELLENT POLICE SERVICE AWARD TO OFFICER NICK VENTRELLA OF THE GATES POLICE DEPARTMENT

Gates Police Chief Rob Long recognized Officer Nick Ventrella with the Excellent Police Service Award and pin. ## PRESENTATING A CERTIFICATE OF RECOGNITION OF HEROIC ACTIONS OF JEFF WEST

Councilman Steve Tucciarello presented a Certificate of Recognition of Heroic actions to Jeff West.

On May 17<sup>th</sup>, while driving by a house on Foxshire Dr., Jeff observed heavy smoke coming from the back. He stopped simultaneously with a neighbor, observing a vehicle in the driveway, instructed the neighbor to call 911 and to alert any occupants. The resident in the home was

unaware of the fire. Jeff proceeded to the back of the home, noticed a neighbor's garden hose and proceeded to extinguish the fire. Gates Police assisted with entry to the home and Gates Fire arrived shortly thereafter.

Supervisor Giunta congratulated and thanked Mr. West for stepping up as the fire occurred 2 houses away from his, helping a neighbor and his neighborhood.

Mr. West Thanked the board for the recognition, one he was not expecting. He was grateful for a neighbor who was there to help out and they did what needed to be done and happy no one was hurt

Supervisor Giunta asked if there was anyone else who would like to speak in audience participation.

Jacob Rink. 98 Arrowhead Dr. Thanked the board for the opportunity to speak, he has never done this before. He is not a negative person and doesn't like to complain, but to voice his concerns against the chip / fog seal process scheduled for his street and neighboring streets. The neighbors feel the same, he presented the board with a letter which he read, along with signed petitions. He spoke on the concerns of the process and asked for this project to be cancelled.

Supervisor Giunta replied Gates is not the only town that uses this process and disagrees with his comments. He's not sure of the schedule and where they are in that, to be able to cancel, but will reach out to Kurt Rappazzo, the Highway Superintendent, who is out of town for the week.

Attorney Schum clarified the Highway superintendent is in charge of the duty and responsible for the maintenance of the roadways by law. He submits a list of roads intended to be addressed throughout the year and the board approves it. They work together.

Supervisor Giunta will touch based to see where the project stands and if possible to be cancelled and revisited. Meanwhile he will contact the foremen as well.

- SECTION II. That the Town Board finds and determines that such legislative action is a Type 2 Action and as such is an Action that will have no significant adverse environmental impact and this resolution shall be considered a Negative Declaration pursuant to the provisions of SEQR.
- <u>SECTION III</u>. That the town Board may take such further action with respect to such proposed Local Law without further regard to SEQR.

## ENACTING INTRODUCTORY LOCAL LAW #3-2023 AMENDING CERTAIN PROVISIONS OF CHAPTER 131 (PARKING) AND CHAPTER 133 (PROPERTY MAINTENANCE)

**WHEREAS**, the Town Board of the Town of Gates did hold and conduct a public hearing to consider the enactment of Introductory Local Law #3-2023 proposing to amend certain provisions of Chapter 131 (Parking) and Chapter 133 (Property Maintenance) which public hearing was held and conducted at a regular meeting thereof held on the 5<sup>th</sup> day of June, 2023 at 7:00 pm at the

Gates Community Center, 1605 Buffalo Road, Rochester, New York 14624 and at which hearing all interested persons were heard concerning the subject matter thereof; and

WHEREAS, the Town Board of the Town of Gates is desirous of enacting such Local Law; and

**WHEREAS,** the Town Board of the Town of Gates did heretofore adopt such Negative Declaration of Environmental Significance with respect to the enactment of such Local Law; **NOWTHEREFORE,** be it RESOLVED by the Town Board of the Town of Gates, Monroe County, New York as follows:

SECTION I. That by the adoption of this resolution the Town Board of the Town of Gates does hereby enact Introductory Local Law #3-2023 which Local Law proposes to amend certain provisions of Chapter 131 (Parking) and Chapter 133 (Property Maintenance).

### **INTRODUCTORY LOCAL LAW #3-2023**

This Local Law proposes to amend Chapter 131 (Parking) and 133 (Property Maintenance) of the Town of Gates Code to read and provide as follows:

<u>ADD</u> § 131-4A(10) Upon any unpaved, grassed or landscaped area within the public right-of-way of any roadway or immediately adjacent to the paved portion of any public roadway.

This Local Law proposes to amend Chapter 133 (Property Maintenance) of the Town of Gates Code to read and provide as follows:

<u>AMEND</u> § 133-8.c.(1)(a) Be ahead of the front line of any principal building unless located within an approved driveway or parking lot.

<u>ADD</u> § 133-8.c.(1)(e) in R-1-8, R-1-11 and R-1-15 zones the parking of commercial or recreational vehicles shall be restricted to the rear of the front line of the residence.

SECTION II. That the Town Clerk shall give due notice of the enactment of this Local Law by filing of the same with eh Secretary of State as required by statue.
