# CONSIDERING A CONDITIONAL USE PERMITS FOR ALEX IMPERATORE (THE HAMPSHIRE COMPANIES) TO OPERATE MAVIS DISCOUNT TIRES AT 410 SPENCERPORT RD. IN A NEIGHBORHOOD BUSINESS (NB) DISTRICT

The Deputy Town Attorney, Robert MacClaren verified that the Legal Notice was properly published as required by law.

Supervisor Giunta asked if the applicant was present to speak on this application. He continued and stated that this is a formality, the business has been there over ten (10) years and is just under new ownership.

Robert Faulkner, 1410 Spencerport Rd, Mavis representative agreed with the Supervisor nothing has changed except for ownership. The hours of operation are:

#### ADOPTING THE 2024 TENATIVE BUDGET AS THE PRELIMINARY BUDGET

Supervisor Giunta, stated there was a Tentative Budget Workshop held on October 16, 2023 which went well and in attendance were the Town Board, the Finance Director and several residents. He summarized the tentative budget and highlighted a few items. Total budget for 2024 is \$23,109,289 million less \$9,795,580 estimated revenue. The town is appropriating \$1,245,000 from fund balance leaving \$12,068,709 million to be raised in taxes. Stated with inflation and increase in cost across the board they felt and agreed that a five cent (\$.05) per thousand increase was appropriate. He continued by saying that the tax rate has been flat at \$6.11 for the past four (4) years and next year will increase to \$6.16 per thousand. However, included with the slight increase is the approval to hire three (3) new officers into the police department bringing them up to thirty-six (36). He stated that they have heard the concerns of the residents on public safety and that public safety is this board's number 1 priority. He believes it's a good value for this slight increase. The good news is the tax cap will not be overridden and the town will stay under the two-percent (2%).

#### **RESOLUTION 153-23**

Supervisor Giunta then opened it up to the floor for any comments.

Councilman Tucciarello said a few words about his concerns with the budgeting because of the inflation rate in our country being very high the last few years, and what we can do in relief for our residents while still providing them services they all have come to expect and to continue to make the happy with what we do in the town. He feels this budget does it and commends Supervisor Giunta, the Finance Director, Stephanie Soto and all the Department heads for working hard on this and with minimal movement in the tax rate. He feels we are getting a lot out of it including three (3) additional police officers, which for public safety is very important. He thinks this is an excellent budget and that it accomplishes a lot with great set of priorities.

Supervisor Giunta thanked the councilman and also the finance director, Stephanie Soto for all her hard work and efforts. This process starts early in the summer, pulling last year's budget and working with all the department heads trying to them present their best budget forward, making sure things are justifiable. He believes this budget is a win, win. They do not want to take away any services from the residents and try only to enhance or improve them. Always keeping the residents in mind.

Councilman DiPonzio echoed the same sentiments.

Councilman Loughlin also agreed with Councilman Tucciarello adding he put it very well and appreciates all the work the Supervisor, Stephanie and the Department heads did, working together compiling this budget and the concessions made to make sure to maintain fiscal responsibility to the residents and keeping the taxes low.

Public Hearing was then close by Supervisor Giunta after motion was made to adopt the 2024 Final Budget.

#### 7:30PM REGULAR TOWN BOARD MEETING

Supervisor Cosmo Giunta called the meeting to order at 7:30PM. He began with a moment of silent prayer and Pledge of Allegiance, led by Councilman DiPonzio.

There were no revisions made to the Public Hearings and regular Town Board Meeting minutes from October 2, 2023 and will be published as drafted and available on the website and in the Town Clerk's office

#### **AUDIENCE PARTICIPATION**

Anthony Cardinale just moved from Buffalo to Gates on 19 Abby Lane to their dream home. He wanted to know why there are several companies picking-up trash instead of one? It seems that everyday of the week there are trash bins on the curbs.

Supervisor Giunta agreed, there is, but in the town of Gates, it's always been allowed to have multiple companies as long as they are licensed and approved by the town. They pay an annual fee to do so. He believes at this time there are five (5) approved / licensed companies, giving the residents choices. There has been some talk on revisiting this and possibly having garbage districts. This would allow a garbage company to bid for a section of the town or district of the town and if it they bid successfully the town would be allocated it on their tax bill and then every resident in that district would have garbage collected by "XYZ" company. It is done in other towns as well as the City of Rochester. It hasn't really been investigated, but could be entertained down the road.

Laurie Clocksin, 69 Coldwater Rd. referred to an email she sent to the Supervisor asking if the town had changed their position on marijuana dispensaries in Gates, to which he responded, No. Then she continued asking about Kingdom Wellness Dispensary on Elmgrove Rd.?

Supervisor Giunta responded he asked the Town Code Enforcer to look into it and honestly didn't know the result due to him being on vacation and wasn't sure if he had responded with all the backlog he had to respond to as well. The Supervisor continued, they have not changed their position, there are no dispensaries in the Town of Gates or retail sales of marijuana.

Mrs. Clocksin wants the town and police to look into this matter further, she feels like things are getting in under the radar, with the laws in NY and is very concerned. She continued and then asked about Amazon, not thinking they are currently operating and if not, what is the date they breach their contract? She thought they would at least be open before Christmas. Supervisor Giunta responded, they have been open for about three (3) weeks now receiving and bringing in inventory to stock the warehouse. Employees have started working there already.. He believes 1<sup>st</sup> shipment out of this facility is scheduled for the end of November, beginning of December.

Mrs. Clocksin, doesn't believe Amazon is forthright and understands there are people in the building. She also had a few other concerns with the trucks going down Buffalo Rd. and doesn't feel they follow the things that were agreed upon.

Supervisor Giunta, responded there was a recent history "Tour around Gates" there was a stop at Amazon in which a tour inside the facility was provided and they were very accommodating. They are working, training, they are also still hiring and are about half of their targeted number of employees. As far as the truck going down Buffalo Rd, he wasn't sure about, but will contact and revisit that with Amazon.

Mrs. Clocksin also didn't understand why it took so long for the new town website to get up and running and feels there was unaccountability during that time including the planning board. She doesn't understand when and how developments near the IACC were approved without her knowing

Supervisor Giunta responded the development she is referring to went before the town board for a rezoning and was in the queue for well over a year with a prior developer that was eventually was rejected and then a new developer purchased a total of eighty-five (85) acres. That was publicized for town board and planning board.

Mrs. Clocksin doesn't understand how she missed all that.

Supervisor Giunta reminded her, that anytime she reached out for information, it was given to her, including having agendas and minutes emailed to her. She agreed she did receive, but still has other concerns with other things.

Leilani McGrath, 396 Hinchey Rd. neighbors are still concerned with the possibilities of development of the Dolomite property. She has a proposal of possibly having an informational meeting to update everyone or make it part of the town board agenda so there isn't a lingering question. The biggest concern of the neighbors is wondering what is happening?

Supervisor Giunta appreciates the suggestion, but there is nothing to update. They haven't done anything, not even discussed further since that meeting. He continued, that they are still looking and feels he can't emphasize enough, it was just a proposal.

Councilman DiPonzio it was part of the original agreement, that it was used part for park and or town purposes.

Supervisor Giunta, stated as he explained before, it was just a conceptual plan. There are grants possibilities to help with developing, but there are no changes, it's been put on the back burner.

Mrs. McGrath also suggested the 34 Acres of 3400 block of Buffalo Rd that's for sale as a possible location.

Supervisor Giunta that has already been purchased, it is part of the eight-five (85) acre project spoken about earlier.

Councilman DiPonzio when Mark Assini was in office he also looked at a number of spots as well and this exploratory venture looking at the Dolomite property was all part of it and some of the things people brought up were things they had already explored and were either flat out turned down. The highway department is sixty (60) years old and has outgrown the need.

Mrs. McGrath asked how is going from the roughly seven (7) acres to needing twenty (20) acres justified. How is it justifies having an eighteen thousand (18,000) square foot garage to a sixty thousand (60,000) square foot garage?

Supervisor Giunta because it would be utilized for other town things. To have a self-serving area, EV stations, mulch pickup or dropping things off. Looking at expanding the current use and make it more resident friendly. Looking at other facilities throughout the county and seeing what they have done and what would be nice for our residents. He gave an example of during the pandemic and was invited to Irondequoit, which is a beautiful facility with the ability to do much more and were able to have residents drive through. It could also be used as a disaster recovery site if need be. They are looking into the future.

Mrs. McGrath is totally behind as far as promoting and progressing forward with the Town of Gates, but also understands the concerns her neighbors have as well and askes for possibly holding a meeting to state this.

Supervisor Giunta the informational meeting that was held was really just supposed to address talks and rumors that were flowing out there, but it turned out to be a bashing session that was unnecessary and doesn't want a repeat of that, especially when there is nothing new going on. Something like this would need to go through many meetings and a referendum.

Councilman Loughlin, if there is no movement, there is no need for a meeting

Mrs. McGrath, maybe possibly add to the cornerstone booklet

Councilman Tucciarello added, in situations like this, there are always folks out there that are enticing you to follow them down a rabbit hole, where the only thing down there is questions. They enjoy this, they want to keep you at the edge of your seat, they want to feed you information that sounds so professional and endearing, but there is nothing to it. This is what happens and how a neighborhood gets upset with something that isn't real. So, the neighborhood anxiety over this, shouldn't be there at all, because there is no plan, there is nothing at all and for them to even make a move there, the residents would need to go to the voting booth. There would need to be a referendum. So that would be a big marker in the mind if a referendum was called, but that's not happening and it's not even a thought at this time. Unfortunately, the neighborhood is being stirred up by folks that want to stir them stirred up and feeling this way. The neighbors will know if there is ever anything to it because they will be able to go and vote down. There is no need to be upset about this, there has been zero discussion about this since that informational meeting, which really was just a meeting to say, there is a lot of misinformation out there. The residents are invited to come to the town hall at anytime and ask questions anytime they want. This town board, the supervisor, this administration has always been extremely open and honest. They feel it's their mission to serve the residents as best as they can with total openness and honesty. It's our job, our mission, they too are residents of this town and are proud of this town and the work they do. They certainty will not do or could do anything underhandedly. Relax, a bulldozer will not just show up, it wouldn't and couldn't happen that way.

Mrs. McGrath understands and that's why she suggests posting that somehow, publishing it so it would go in everyone's mailbox and if they read the letter back in January of 2022 asking people to go to the library and give input, which is how her first conversation started.

Supervisor Giunta they try to keep everyone informed using the website and social media and now the cornerstone.
