### **7:10PM PUBLIC HEARING**

The Town Attorney, Dan Schum verified that the Legal Notice was properly published as required by law.

#### **TO CONSIDER GRANTING A CABLE TELEVISION FRANCHISE AGREEMENT BY AND BETWEEN THE TOWN OF GATES AND SPECTRUM NORTHEAST, LLC AN INDIRECT SUBSIDIARY OF CHARTER COMMUNICATIONS**

Supervisor Giunta, stated this is just standard protocol. It's a fifteen (15) year renewal with Spectrum and just gives them the rights-of-way to put on telephone poles to run into people's homes for cable and internet services. It's a standard franchise agreement allowing to do so in the Town of Gates.

Attorney Schum added the purpose of a public hearing is to allow anyone from the public to speak for or against this application. Principally if there are areas of service that have poor or no service within the town, it should be brought to the attention of the town board presently. There is an ongoing obligation to provide such service and board needs to be made aware if certain areas are not being served.

Supervisor Giunta asked if anyone from the audience wanted to speak for or against this?

Laurie Clocksin,, 69 Coldwater Rd. wanted clarification on the telephone poles being used

Supervisor Giunta explained this is allowing Spectrum to run their lines on the telephone poles and also the ability to go through the easements to provide services for residents in the Town of Gates.

Mrs. Clocksin asked how would this effect people who do no have or want cable.

Supervisor Giunta, it doesn't.

Attorney Schum added Spectrum does not have the right to enter onto private property for furnish or try to sell you anything.

Mrs. Clocksin asked if the lines will be running from pole to pole? She has noticed a horrible state of the infrastructure, with multiple companies putting up their equipment using public utilities for 5G, cables are sagging and an eyesore and can't imagine it getting must worse. She does not agree and apposes to this, she doesn't have cable TV and doesn't want it.

Supervisor Giunta, thanked her for her comments and closed the public hearing at 7:15pm.

Councilman Tucciarello added this is a continuation of something that has already been going on for a long time, bringing necessary services to the residents in this point in time and in the evolution of the world and to not do this would devalue our town greatly of services like internet, cable and so forth. This is a good contract

#### **MORATORIUM ON SMOKE & VAPE SHOPS**

Supervisor Giunta looking to establish a local law for a hold/freeze, six-month moratorium on any new smoke or vape shops coming into the Town of Gates. There is currently about ten (10) smoke shops within the Town of Gates and want to get a hold on this. Implementing this Local Law gives the town ample time to revisit the code and any modifications necessary to structure this better. Gates is not the only town experiencing this influx of smoke shops, they are opening in gas stations and certain store fronts.

Attorney Schum added the Gates Police Chief and his officers have been doing a great amount of proactive enforcement of the existing laws. The Town of Gates opted out of the legal sale of cannabis, so there are no dispensaries allowed in the Town of Gates and to despite that there have been some smoke shops that offered marijuana and marijuana products as well as vape products to underage people and the chief and his crew have done a wonderful job encouraging compliance with the existing laws, while we as the town along with other towns are trying to at least segregate, locate and regulate that activity. Smoke shops are not illegal if they are selling legal products but when they are and to underage people, that creates a violation of state and local law.

Supervisor Giunta asked if anyone from the audience wanted to speak on this, hearing none closed the public hearing at 7:23.

## **7:30PM      REGULAR TOWN BOARD MEETING**

Supervisor Cosmo Giunta called the meeting to order at 7:30PM. He began with a moment of silent prayer and Pledge of Allegiance, led by Councilman Tucciarello.

There were no revisions made to the regular Town Board Meeting minutes from February 5, 2024 and will be published as drafted and available on the website and in the Town Clerk's office

### **AUDIENCE PARTICIPATION**

Hailey Sims, 44 Snowberry Crescent, representing herself and the people in her neighborhood. She explained the property behind the townhouse at 3399 Lyell Rd., which is between Snowberry Crescent and Ann Marie Drive. are full of very tall dead and dangerous trees as well as overgrown poisonous plants. Her backyard backs up to this property which she presents photos and copies of multiple filed complaints. She is fearful that a person or pet could get hurt. She herself has had multiple trees cause over \$2000 in damages to her property and has taken the property owner to court and was awarded damages. She continued reading a statement to the board with dates and further information. She is asking for answers and assistance. There is no safety protocol and the property owner is not taking care of the issue.

Supervisor Giunta told Ms. Sims that as far as the trees, the town will look into and take care of, but being a conservation easement makes it a bit more difficult.

Attorney Schum, at the planning board meeting Ms. Sims attended it was discussed there is a town statute that allows the homeowner to file a complaint with the town and then there is a process to see if whether or not the trees are dead or dangerous. He then asked her if she file a complaint after that meeting?

Ms. Sims replied she tried, but was turned away because of the easement. She has been working on this for over two years.

Attorney Schum the conservation easement does not absolve the property owner from taking care of the property. The town cannot compel the property owner to comply with the law.

Supervisor Giunta added he will follow-up with the Code Enforcer

Mattie Miles, 32 Snowberry Crescent has dead trees on both sides coming down onto her property and when she spoke with Mr. Licciardello she was told to file with her insurance. So, if each time this happens, she files with her insurance company, they will eventually drop her. Her complaint was filed December 2022 and hasn't heard anything.

Supervisor Giunta apologized for not hearing anything and asked for some time to look into it.

Sherry Hellard, 44 Snowberry lives with her daughter and has met a lot of the neighbors who are disgusted with the lack of addressing the tree situation. She is fearful of the trees coming down on to the house as well as being an eyesore. They just want a beautiful place to live. She continued to address some of the other neighbors' issues with the trees and invited the board to the house to see for themselves.

Kurt Rappazzo, Director of Public Works had some clarifying questions. The first complaint, was is about trees that had already fallen?

Ms. Sims, yes it was about damages from trees. She called the Town and at that point, Mr. Licciardello did come out and removed part of the tree. But did not address any of the other dead trees.

Mr. Rappazzo wanted to make it clear, that the first complaint was about trees that had already fallen and obviously with our tree code, the conservation is about trees already standing. The town should have taken a better look at the trees that were already there and addressed at that point. He understands they are upset about the filing and dates and the conservation easement, but that conservation easement has been in place ever since that subdivision was done, probably eight to ten (8-10) years ago, but the actual language of the easement was not filed, so when the complaint came in and saw there was a conservation easement and looked for the paperwork and it was there and crated it and got it filed. He agreed with Ms. Simms on all the language in that agreement.

Second, which he addressed to the Town Attorney, since Ms. Simms already took Mr. Licciardello to small claims court can the town still act on it?

Attorney Schum asked Ms. Simms if the judgment she received from Ogden court was for the complaint submitted for the tree or trees that were dangerous or had fallen? Ms. Simms replied, yes, but hasn't collected yet.

Attorney Schum, to answer Mr. Rappazzo, the collection of that judgement is beyond what the town can enforce or not enforce, but does that preclude us from forcing the conservation easement? No, Does it preclude the town from the dangerous tree code? No

Supervisor Giunta asked for clarification about Ms. Simms initial complaint. Was it before the tree had fallen? She responded, Yes. He told her to give him some time to look into further.

Mrs. Clocksin asked for some clarification on the smoke shops and Supervisor Giunta referred her to Chief Long off line.
